- ii. If he is further aware that the power was disconnected recently by the Kenya Power and Lightning Company (KPLC) due to accrued unpaid water bills?
- iii. What measures has the County Government put in place to rectify water scarcity and come up with permanent solution including a cheaper source of power?

022/2021: Hon. Lotela Nelson, MCA, Silale Ward, seeks a statement from the **Chairperson Education, Vocational Training and ICT Committee** on the following matters of concern:

- i. What action was taken against the contractor who deliberately abandoned Akule, Napukut and Toplen ECDE classes which have stalled for long?
- ii. Which company or companies won the tenders for construction of these ECDE classes, how many other ECDE classes in Tiaty did the contractor abandon, and whether they have all stalled?
- iii. When will the department complete the above ECDE classes for use as it has taken over 5 years for the projects to be completed?
