005/2020: Hon. Sam Limo Lourien, MCA, Tirioko Ward, seeks a statement from the Chairperson Education, Vocational Training and ICT Committee on the following matters of concern:

- i.If he is aware that during the 2017/2018 Financial Year, ten plastic water tanks of 10,000 litre capacities were budgeted to be bought for ten (10) Tirioko ward ECDE centres?
- ii.If he is further aware that the ten tanks were to be distributed to the following ECDE centres namely:
 - a) Domo ECDE
 - b) Chemayes ECDE
 - c) Dira ECDE
 - d) Kangiruru ECDE
 - e) Kreze ECDE
 - f) Chischis ECDE
 - g) Katagh ECDE
 - h) Loyamoi ECDE
 - i) Chepkirial ECDE
 - j) Kamurio ECDE
- iii.Can the Chairperson confirm if the said tanks actually reached the intended ECDE centres?
- iv.Can the Chairperson without the use of signed list from the department table before this Honourable House the acknowledgment and or receipt letters of the said

tanks from each of the intended ECDE centres with photographical evidence on the availability of the said tanks in each of the listed centres?

v. What measures is the County Government taking to ensure that the said tanks are availed to the respective ECDE centres?

015/2021: Hon. John Tarus, MCA, Sacho Ward, seeks a statement from the Chairperson Transport, Public Works and Infrastructure Committee on the following matters of concern:

- i. If he is aware that there are road construction plants/machines purchased as County/ Sub-County/ Ward based machinery?
- ii. When were the said plants/machines purchased?
- iii. How many are they (give the number and the type of the plants/machines) per County, Sub-County and Ward respectively.
- iv. Giving the reasons in each case, how many of these plants/machines are not working?
- v. If he is further aware that there are dozers, excavators, lorries and other machineries that are not serviceable but they have been left unserviced for many years?
- vi. Is there any regulation in place to operationalize these machineries?
- vii. What plans has the department put in place to make sure that the plants/machines are in good condition to offer services to the people of Baringo?

- viii. Are there operators permanently employed or on contract to operate these plants/machines?
 - ix. Give the list of the operators, their years and terms of service?
 - x. For how long have they remained unpaid?

022/2021: Hon. Lotela Nelson, MCA, Silale Ward, seeks a statement from the **Chairperson Education, Vocational Training and ICT Committee** on the following matters of concern:

- i. What action was taken against the contractor who deliberately abandoned Akule, Napukut and Toplen ECDE classes which have stalled for long?
- ii. Which company or companies won the tenders for construction of these ECDE classes, how many other ECDE classes in Tiaty did the contractor abandon, and whether they have all stalled?
- iii. When will the department complete the above ECDE classes for use as it has taken over 5 years for the projects to be completed?

 (Hon. Lotela Nelson, CECM and the Chairperson Education, Vocational Training and ICT Committee to organize for a consultation meeting to iron out the issue at hand and present a comprehensive report to the House in two weeks time)

025/2021: Hon. Elizabeth, MCA, Baringo County, seeks a statement from the Chairperson Health Services Committee on the following matters of concern:

- i. If he is aware that asbestos used in roofing construction is a silent killer which can often go unnoticed, and the idea of its presence in the building surrounding people is enough to create feelings of uneasiness and concerns health-wise?
- ii. Can the Chairperson provide details of the number of casualties who have suffered as a result of use of asbestos roofing materials since the dangers of asbestos poisoning have been well documented and has been banned in other countries such as the United Kingdom?
- iii. Can the Chairperson inform this House if adequate civic education has been conducted to educate the people of Baringo County of the adverse effects of the use of asbestos as roofing material?
- iv. Can the Chairperson further inform this House if he is aware that when asbestos fibers become loose and potentially airborne and when inhaled pose a risk to dangerous diseases such as lung cancer, pleural thickening etc. and if so, what is the County Government doing to avert these risks?

026/2021: Hon. Joel Kipchew, MCA, Kabartonjo Ward, seeks a statement from the Chairperson Transport, Public Works and Infrastructure Committee on the following matters of concern:

i. If he is aware that there was Ksh. 2,000,000 allocated for fuel for road machinery to be used in the opening up, grading and gravelling of various roads in Kabartonjo Ward in FY 2020/2021?

- ii. If he is also aware that in the FY 2021/2022 the above mentioned amount was reduced from Ksh. 2,000,000 to Ksh. 400,000 yet there are no roads that have been constructed?
- iii. Can the Chairperson list and name the roads that were rehabilitated if any using the Ksh. 1,600,000 meant for fuel that was reduced after the 1st Supplementary budget of 2021?
- iv. Can the Chairperson further inform this House who used the allocation meant for fuel for the rehabilitation of the roads if no road was constructed?
- v. What plans is the department putting in place to ensure that the Ksh. 1,600,000 budgeted for road machinery fuel is reinstated and re-budgeted for its intended purpose?
